## IICA MTP 2022-2026

#### g Food Safety Systems in the Caribbean

(IICA) is a specialized agency of the Inter-American System that supports the efforts of its Member States to achieve agricultural development and rural well-being.

Provides technical cooperation continuous engagement with its 34 Member States, based on the needs of their agrifood systems.

IICA supports 15 Caribbean countries

Harmonize, update and implement science-based health, safety and quality standards, promoting the harmonization, updating and implementation of SPS measures, within the framework of the Application of SPS Measures, the Trade Facilitation and the Technical Barriers to Trade agreements ------

BY strengthening technical capacities for decision making and institutional capacities for the implementation of these agreements

One such area under the AHFSQ program is Codex



# **Pre-COVID – Delegates**

General Session & Codex Committees

- Participation in virtual colloquiums (IICA invited candidates to come to IICA Office to view sessions and be able to discuss with other colleagues and stakeholders)
- IICA provided support to attend committee meetings through a competitive application process (not all countries submitted proposals) – some countries went with own resources, most Caribbean countries could only attend with IICA support – poor participation or ineffective participation



### Strengthening Food Safety Systems in the Caribbean IICA Support – Promotion of Participation

- In 2000 IICA conducted a survey in 24 countries in LAC, results showed only 15 (62.5%) countries indicated active participation
- As a **Consequences of low or NO participation IICA developed a programme in Oct 2009 for** 'Promotion of the participation of the Americas in the CA' – the activity was intended for:
  - Funding for codex delegates
  - Provide opportunity to coordinate actions and establish a national agenda articulated in Codex issues &
  - Achieve a greater regional coordination of positions
- After 7 years, the results were evaluated




## **ACHIEVEMENTS OF PROGRAMME**

- <u>Coverage</u>: 32 countries members of the IICA and Codex (excluding the United States and Canada).
- <u>Financing of:</u> IICA, USA, Canada, private sector.
- Funding for: Participation/development of capacities/ south south cooperation.

#### Achievment from the Programme

- 7 years of program
- 43 meetings of committees supported
- 12 committees supported
- 252 officials supported
- 30 Countries Supported





## **Other support actions in Codex**



- Supported and implemented training events and strategic planning in LA & Caribbean countries
- FAO/WHO CCLAC in its management and promotion of regional coordination
- ✓ Codex Symposiums, inter regional meetings among CCLAC-CCAFRICA-USDA
- Colloquio/Colloquiums countries discuss and reach consensus on topics of the Codex Alimentarius, prior to the meetings of the committees, thus improving its negotiating position.
- Twinning Programmes drawing on the capabilities and positive experiences of other LAC countries or other regions to complements the efforts of USDA& IICA to strengthen the CAC
  - 2016 ECS (5 countries) & Brazil plus one additionnal outcome: Development of an "e-Codex ECS Sub Regional Newtork" – only one meeting held to discuss TOR
  - 2016 A&B & US Codex
  - **2017** Bahamas+ twin & Jamaica+twin

# **Other support actions parallel in Codex**

- Support for the coordinating country of the CCLAC (Chile & Ecuador)
- Video Conferences of coordination, prior to meetings of the Codex Committees (more than 60 meetings) – urge country to participate even if not attending the CC Meeting.
- Training
- Direct participation in some Codex committees at the national level and/or work together at the national level.

# Support - collaboration

#### Participate in General Session & Codex Committees

- CCLAC Coordination meeting on various committees
- 2020- 15 CCLAC virtual meetings planned (all physical sessions were cancelled, 3 physical inter-colloquiums cancelled, virtual committee meetings were held, poor participation from countries, livelihood disrupted by lockdowns, illness and death )

• CAC43 –CAC43 for the first time held virtually by members consensus.

# Support for building capacity of NCC

- Codex NCC (CCP) professionals capacity to coordinate Codex Alimentarius was enhanced through direct technical support and facilitation of national codex delegates to prepare for, and effectively participate in: -
  - a specialized training provided 2 officers from countries to develop skills for effectively participating in codex meetings via a Virtual 'Online Consensus Formation' course,
  - IICA-hosted CCLAC meeting for LAC countries 'Challenges and Opportunities of the LAC Region in the Codex Alimentarius, in the new normal',
